# Curriculum at the Healing Arts Institute Massage Therapy Program Healing

#### **500 Hour Massage Program**

Here is a detailed breakdown of the Massage Therapy Program at the Healing Arts Institute EGF MN

Therapeutic Massage – 200 Hours – Provides comprehensive academic instruction in the theory of massage therapy, supervised hands-on instruction in massage and bodywork assessment, and application instruction as well as practical skills training such as Palpation, Body Mechanics, Draping, Swedish Massage Techniques, Deep Tissue Techniques, Integrated Massage Techniques and how each affects the physiology of the body. This section also includes the Massage Student Clinic during which the students demonstrate massage on instructors, other students and the public to better prepare them for their future massage practice.

**Anatomy & Physiology** – 90 Hours –Students learn the structures and functions of each body system and the mechanisms that control these functions. This information is an essential part of massage therapy training because it will greatly enhance your ability to use appropriate precaution when giving massages and will reinforce your understanding of the physiological effects of massage therapy.

**Kinesiology** – 35 Hours - Kinesiology is the study and the detailed understanding of how the human body works, moves and responds to mental messages. This will include origins, insertions, and actions.

**Pathology** – 40 Hours - Pathology is the study of the nature and causes of disease. Since the number of pathologies we humans may encounter is practically limitless, we focus on pathologies that are specific to massage therapy. Thus we can judge whether our work is appropriate for the client. This knowledge allows us to create safety, trust and credibility with our clients.

**Massage Basic Knowledge** – 65 Hours – This portion of the massage program will address: Contra-indications, Benefits of Massage, Universal Precautions, , Legalities of Massage, Professional Standards of Draping and Modesty, History of Massage.

Allied Therapies and Spa Services - 50 hours - Hydro Therapy, Aroma Therapy, Body Wraps, Exfoliating Scrubs, Hot/Cold Stone Therapies, Warm Bamboo Massage, Massage Cupping, Reflexology, Acupressure, Thai Massage, Energy balancing, Therapeutic Stretching & Sports Massage, and Chair Massage.

First Aid, Hygiene & CPR – 10 Hours - First Aid, Hygiene, CPR, and Safety as a Massage Therapist.

**Ethics** – 6 hours – The Standards of Practice and Code of Ethics provide Massage Therapists with clear directions in a comprehensive document from which they can obtain guidance on how well they are expected to perform their various tasks within the Scope of Practice.

**Business Practices** – 4 hours – This course will prepare the student to go out and start their career in the massage industry. Learn the different types of massage employment and write a professional resume.

# Refund Policy

- For applicants who cancel within three (3) business days after signing the enrollment agreement or at least 1 week prior to start of 1st class, all monies will be fully refunded minus the application fee
- After the first day of class, the application fee and enrollment agreement fee are non-refundable.
